MYSTIC FESTIVAL 2024 CAMPING GROUNDS TERMS AND CONDITIONS

- 1. The following document, hereinafter referred to as "Terms and Conditions," pertains to all those present at the camping grounds available from June 4, 2024 from 4:00 PM up until June 9, 2024 till 12:00 PM on the area designated by the Organiser, that is the Plac Zebrań Ludowych in Gdańsk, near the Ofiar Katynia roundabout, hereinafter referred to as "Camping Grounds." The Camping Grounds have been organised to be used for the Mystic Festival 2024, taking place from June 5 until 8, 2024, hereinafter referred to as "the Festival."
- 2. The Terms and Conditions have been issued by the organiser of the Festival Mystic Coalition Company, Limited, which figures in the Polish Register of Entrepreneurs of the National Court Register, KRS number 0000754728, NIP 5130257272, REGION 38163305200000, address: Minoga 127 32-046, Kraków, hereinafter referred to as "The Organiser."
- 3. The right to purchase an entry ticket for the Camping Grounds is reserved only for those who have purchased a pass for the Festival.
- 4. The right to enter the Camping Grounds is reserved for those who show their entry ticket for the Camping Grounds or who were granted an individual right of entry to the Camping Grounds by the Organiser, with reservations described in the 6th paragraph.
- 5. A minor under 16 is allowed the right of entry to the Camping Grounds only if they are under the supervision of an adult guardian/parent, after showing entry tickets for the Camping Grounds by both the minor (with the reservation that a minor under 13 does not need to have an entry ticket for the Camping Grounds) and their adult guardian/parent and after showing a document that confirms the age of the minor, and submitting to the Organiser a declaration of responsibility for a minor by the legal guardian/parent according to the template found in the **annex to the Terms and Conditions**.
- 6. Before the first entry to the Camping Grounds the entry ticket for the Camping Grounds will be scanned and exchanged by the Organiser for an ID bracelet, hereinafter referred to as "**ID**," which is required to be worn by each person entitled to enter the Camping Grounds for the entire time the Camping Grounds is available. One ID can be used by one person only. Giving your ID to a different person is strictly forbidden. The right to stay on the Camping Grounds as well as each entry

to the Camping Grounds is restricted only to those who possess an undamaged ID issued by the Organiser.

The unique bar code present on each entry ticket allows for exchanging the ticket for an ID only after the first scan.

- 7. The Camping Grounds will be looked after by security personnel, hereinafter referred to as "Security Workers," appointed by the Organiser. They will be looking after the safety of the people staying on the Camping Grounds.
- 8. The Security Workers are required to wear an ID issued by the Organiser in a visible way. The ID contains the following information: the issuing party's name, the ID number, a picture of the wearer's face, an expiration date, a stamp and the signature of the issuing party.
- 9. People staying on the Camping Grounds are required to have a valid document confirming their identity, that is a national identity card, a temporary confirmation of identity, a passport, a driver's license, a student or school card, a document confirming the identity of a foreigner or a different document which confirms the identity, containing a picture of the face and stating their age.
- 10. The Security Workers might ask a person entering the Camping Grounds or purchasing a ticket to show a document which confirms their identity and age during the purchase of entry tickets for the Camping Grounds and upon entry to the Camping Grounds.
- 11. People staying at the Camping Grounds are required to behave in a way that will not endanger others and to obey the Terms and Conditions.
- 12. The Security Workers are allowed to:
 - a. check and approve the right to enter and stay at the Camping Grounds and if those rights are not confirmed – to call upon the expulsion from the Camping Grounds,
 - b. ID people to confirm their identity,
 - c. check the contents of any bags and clothes of the people staying at the Camping Grounds if there are any grounds to suspect that they are carrying items which are forbidden according to the Terms and Conditions on the Camping Grounds,
 - d. issue organisational commands to the people who are disrupting public order or do not behave in accordance with the Terms and Conditions, and if

those commands are not followed – force them to leave the Camping Grounds,

- e. capture, in order to hand over to the Police, people whose actions pose a direct threat to items and people protected by the Security Workers as well as people who commit criminal offences.
- 13. The actions of the Security Workers have to be carried out in a way which respects the human dignity and personal belongings of the people against whom the actions are taken.
- 14. Means of physical coercion and the documentation of their usage by the Security Workers is done according to the bill from May 24, 2013, about the means of physical coercion and use of firearms.
- 15. On the Camping Grounds and in their area, it is forbidden to:
 - 1) carry in, possess and use weapons and other dangerous items; explosive materials; pyrotechnic materials; materials which pose a fire hazard; alcoholic drinks that contain more than 4.5 % of alcohol; narcotics and psychotropic substances; stun guns; pepper sprays; knives; baseball bats; chains; firecrackers; smoke bombs; laser pointers; items which can be used as projectiles and the like; all items with sharp ends; gas bottles; camping stoves; drones and other unmanned aerial vehicles,
 - 2) conduct any commercial activities or other money-gaining activities without the permission of the Organiser,
 - 3) smoke outside specially designated areas,
 - 4) satisfy physiological needs outside the toilets,
 - 5) throw any objects,
 - 6) use open fire in the tents and near them,
 - 7) start fires,
 - 8) use barbecue equipment outside specially designated areas,
 - 9) put up tents larger than 10 m2,

10) use the existing electrical installation outside specially designated areas,

11) destroy the greenery,

12) destroy the infrastructure and tents of the Camping Grounds,

13) disrupt the public order and litter,

14) enter with animals, except for service dogs,

- 15)drive and enter the grounds by car, campers, caravans and other vehicles without the Organiser's permission.
- 16. The Security Workers are allowed to:
 - 1) check the right to stay at the Camping Grounds and ID people to determine their identity,
 - ask people to leave the Camping Grounds if a lack of a right to stay in the area, a disturbance of the public order or disobeying the Terms and Conditions is detected,
 - capture any person whose actions overtly threaten human life and wellbeing, as well as protected property on the Camping Grounds to hand them over to the Police immediately,
 - use means of physical coercion on the grounds covered in the bill from August 22, 1997 on the protection of people and property (Dz. U. [Journal of Laws] of 1997 no. 114 item 740 with later amendements),
 - 5) use firearms on the grounds covered in the bill from August 22, 1997 on the protection of people and property (Dz. U. [Journal of Laws] of 1997 no. 114 item 740 with later amendements),
 - 6) deny access to the Camping Grounds and the ability to stay there especially to a person that:
 - a) is under a visible influence of alcohol, narcotics, psychotropic substances or other similar substances,
 - b) carries a weapon or other dangerous object, explosive materials, pyrotechnic materials, materials which pose a fire hazard, alcoholic drinks, narcotics and psychotropic substances or any other products, drinks, resources or substances the possession of which is forbidden by the Terms and Conditions,
 - c) behaves aggressively, provokes or in any other way threatens safety and public order,
 - d) does not have the right to enter the Camping Grounds.
- 17. All people staying on the Camping Grounds are to obey the orders of the Safety Workers. Disobedience is acceptable only if it is the result of the orders being contrary to the generally applicable provisions of law.

- 18. It is forbidden to destroy and interfere with the terrain of the Camping Grounds beyond the works necessary to properly put up and keep a tent. The participants are obliged to return the area used to its previous state at the latest before the period of the Camping Grounds availability terminates.

- 20. The Terms and Conditions come into force on October 1, 2023.

- The willing provision of personal data is necessary for the Administrator to allow the minor to take part in the Event.
- The refusal to give personal data precludes the minor from staying at the Camping Grounds.
